6. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security and scanned copy of the bid security in *pdf* format, amounting to above mention **Bid Bond** which shall be valid for 30 days beyond the validity period of the bid.

In case the last date of submission and opening of the bid falls on a government holiday, the following working day shall be considered the last day and the aforesaid activities shall occur on the same time on the following day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.

8. All the procurement procedures will be carried out under Public Procurement Act, 2007, Public Procurement Regulation, 2007, Financial Procedure Act, 1999 and Financial Procedure Regulation, 2007. This office reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason whatsoever.
